
On March 5, 1999, Beverly S. Ashford and Clinton R. Ashford ("Petitioners") filed a Motion For Order Waiving Requirement Of HAR §15-15-50(c)(8) For Financial Statements ("Motion"), pursuant to sections 15-15-34 and 15-15-70, Hawai'i Administrative Rules ("HAR"). Section 15-15-50(c)(8), HAR, requires the submittal of a statement describing the financial condition together with a current balance sheet and income statement, and a clear description of the manner in which Petitioners propose to finance the proposed use or development.

On March 15, 1999, the Office of Planning ("OP") filed an Office Of Planning Memorandum In Support Of Petitioner's Motion For Order Waiving Requirement Of HAR §15-15-50(c)(8) For Financial Statements.

The Motion came on for hearing before the Land Use Commission ("Commission") on March 18, 1999, in Waikapu, Maui, Hawai'i. Clinton R. Ashford, Esq., appeared on behalf of Petitioners. Ann Ogata-Deal, Esq., appeared on behalf of the OP. The City and County of Honolulu Department of Planning and Permitting was served with a copy of the Motion and did not submit any written response to the Motion nor did it appear at the hearing on this matter.

This Commission, having duly considered Petitioners' Motion and the arguments presented by the parties present in the proceeding, and good cause existing therefrom,

IT IS HEREBY ORDERED that Petitioners' Motion be GRANTED.
