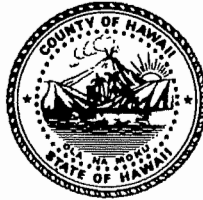

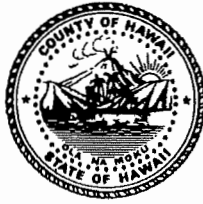

Thank you for your letter dated August 2, 2017 that submitted the 2017 annual progress report to comply with Condition 16 of the subject Special Permit. We appreciate the thoroughness of the report. Based upon review of our records, the report accurately details the progress of project compliance with the required conditions of approval. Our understanding is that the applicant intends to begin quarrying activities shortly after October 1, 2017 to avoid any potential adverse impacts to Hawaiian hoary bats and Hawaiian hawks. Please be aware that Conditions 8, 9 and 10 must be complied with beyond 2017 for the life of the permit.

The next annual progress report is due on or before August 26, 2018.
