Dear Mr. Orodener:

On March 8, 2018, we notified you of an anticipated change in parent company ownership for the above-referenced projects. In our letter, we described the agreement between NRG Energy, Inc. ("NRG") and GIP III Zephyr Acquisition Partners, a subsidiary of Global Infrastructure Partners ("GIP"), for GIP to purchase substantially all of NRG's renewable platform, including Kawailoa Solar, LLC and Waipio PV, LLC (the "Transaction"). We wish to update you with respect to the Transaction.

On August 31, 2018, NRG and GIP concluded the Transaction, and the name of Zephyr Renewables LLC has changed to Clearway Energy Group LLC ("Clearway"). Including assets owned by our affiliate company, Clearway Energy, Inc., Clearway's operating footprint of renewable energy projects includes 2.8 GW of wind, 1.1 GW of utility solar, and over 300 MW of distributed and community solar.¹ Clearway owns an 8.9 GW pipeline of renewable energy projects in development, and provides operations & maintenance and asset management services to 4.1 GW of renewable operating assets.

Clearway sees a bright future with our new sponsor, GIP, who has a commitment and track record of large -scale investments in renewables. GIP's current portfolio includes approximately \$9 billion of equity invested or committed in the sector, and 20+ gigawatts ("GW") of operating, construction and development assets.

¹ MW figures reflect net ownership, as opposed to gross MW capacity, across all facilities.


Clearway includes the same NRG team in operations, maintenance and development staff along with the corporate functions and facilities that support renewables business activities within NRG. That same team is energized and motivated to make clean, competitive and reliable energy for our customers while building an enduring company that does good for our environment, our communities, and our people.

Clearway hereby confirms that (A) the Transaction will not in any way affect Clearway's commitment to completing and operating the two PV projects referenced in the subject line above, or otherwise impact such projects; (B) Clearway does not anticipate any changes to the scope, timeline, development schedules, or operating plans of such projects; (C) Clearway's business dealings will continue as usual, unchanged; and (D) Clearway has committed the resources, capital, and execution expertise to deliver such projects on schedule and in accordance with the contracts and all underlying milestones. In summary, Clearway reaffirms its commitment to these projects.

On behalf of the Clearway team, thank you for your continued partnership. We look forward to continuing to build a strong renewable energy future for Hawaii.
