Reference is hereby made to SUP Nos. 2014/SUP-6 and SP15-406 (County Conditions 9 and 8, respectively) and CUP No. 2015/CUP-48 (Condition I) relating to the approximately 49 MWac solar photovoltaic generating facility known as the Kawailoa solar project.

Kawailoa Solar, LLC ("Permittee") hereby notifies you of the pending purchase by DESRI Kawailoa Renewables Acquisition, L.L.C. ("DESRI KRA"), a subsidiary of D. E. Shaw Renewable Investments, L.L.C. ("DESRI"), of a 51% indirect interest in Permittee (the "Acquisition"), which is anticipated to occur on or around August 1, 2022. Another affiliate of DESRI, DESRI Kawailoa Solar Holdings, L.L.C. ("DESRI Holdings") already holds the other 49% indirect interest in Permittee. Following the Acquisition, Permittee will remain the permittee under the above-referenced permits.

Tracy Camuso of G70 discussed the Acquisition with Mr. Krantz of the Department of Planning and Permitting ("DPP") by telephone on June 27, 2022, and Mr. Krantz confirmed that consummation of the Acquisition does not require the consent of the DPP.


The Acquisition will not cause or require any physical alterations to the operations of the Kawaihoa solar project or its surroundings or otherwise impact its amended power purchase agreement. Permittee's business dealings will continue as usual following the Acquisition.
