(2) A search indicates that the property description information (given as "4-6-11", and "Lot No. 2, Kapahi Homesteads") seems to be incorrect or incomplete, and apparently refers to Tax Map Key: Fourth Division, 4-6-11: 5. (3) After checking with the Attorney General's Office, it is my belief that no existing or proposed regulations of the Land Use Commission will affect your ability to construct accessory uses to your farm operation, including single-family dwellings. For the first two reasons cited above, the application is incomplete and has not been processed. For the third reason, I do not believe you need Land Use Commission permission to build an additional farmhouse on your farm. provided the occupants can be said to be engaged with you in the farming operation.
