### PROCESSING PROCEDURE

#### State Special Use Permit

 "triggered" by special use (quarrying) on State Agricultural designated lands. State Land Use Commission (LUC) approves permits for areas over 15 acres in size; Maui Planning Commission reviews and provides recommendation to LUC on State Special Use Permit.


#### County Special Use Permit


 also "triggered" by special use (quarrying) on County Agricultural zoned lands. Maui Planning Commission approves County Special Use Permits

### REQUEST

# Amendment to Existing State Special Use Permit and County Special Use Permit for the Puunene Quarry

- 1. To extend the boundaries of the existing Puunene Quarry site by adding 42 acres for quarry use;
- 2. To add a 9.697-acre portion to the existing quarry site;
- 3. To delete Condition No. 16 of the State Special Use Permit related to submittal of an updated map to the Department of Planning to reflect the boundary of the previously permitted 105.957-acre quarry site; and
- 4. Request a 15-year time extension for SP92-380, which expires on July 13, 2017 and a 14-year time extension for CUP 2006/0002 which expires on July 21, 2018. The time extensions will provide consistency for the expiration dates (2032) of the SUP and CUP.







### ADDITIONAL PROJECT INFORMATION

- Puunene Quarry amendment requests are not anticipated to have additional impacts to traffic, drainage or other utilities or public services.
- Hawaiian Cement lease with A&B Hawaii includes restoration plan for quarried lands for agricultural use.
- Hawaiian Cement lease also restricts the amount of acreage that can be in active quarry use at any time (no more than 30 acres).
- The quarry material from the site is used for a variety of uses which provided needed material for construction purposes. Additional rock material is needed to support the construction projects on Maui.
