To consider reclassifying approximately 541.769 acres of land currently in the Agricultural District into the Urban District and approximately 12.873 acres of land currently in the Conservation District into the Urban District at Hanamaulu and Kalapaki, Kauai for residential, office, commercial, industrial and public/quasi-public facility uses, open space, and parks.

2. A89-636 - GROVE FARM PROPERTIES, INC. (Kauai)

To consider reclassification of the Second Increment of the subject docket consisting of approximately 108.570 acres of land currently in the Agricultural District into the Urban District at Lihue, Kauai for residential, commercial, golf course, and open space.
