#### ACTION

SP90-375 - STATE OF HAWAII, DEPARTMENT OF LAND AND NATURAL RESOURCES, DIVISION OF FORESTRY AND WILDLIFE (Kauai)

Chairman Nip announced that the Commission would take action to consider the establishment of a commercial sand mining operation and the creation of an endangered waterbird nesting habitat and sanctuary situated at Kekaha, Kauai.

Raymond Young, Staff Planner, oriented the Commission to the special permit area on the Land Use District Boundaries and tax maps and also gave a summary report of the special use permit request.

Comments on the special use permit were heard from Mr. Telfer and Mr. Morimoto. After hearing comments, questions were asked by the Commissioners.

Commissioner Hoe moved for approval of the special use permit subject to four conditions as recommended by the Planning Commission, County of Kauai, and subject to the following conditions:

- 1. That the commercial sand mining operation be established no later than December 31, 1990; and
- 2. That the wild bird sanctuary to commence its functions by December 31, 1991.

The motion was seconded by Commissioner Whittemore and unanimously approved by the following voice votes:

## A81-525 - Y-O LIMITED PARTNERSHIP (Hawaii)

Chairman Nip announced that the Commission would take action to consider Petitioner's Motion for Modification of Condition "A" to Delete the Restraint on Alienation of the Decision and Order dated January 20, 1983 which reclassified approximately 213.473 acres of land from the Agricultural District into the Urban District and reclassified approximately 195.246 acres subject to incremental districting situated at Kaloko and Kohanaiki, North Kona, Hawaii for residential and commercial use.

Commissioner Hoe moved that the motion be granted and that the language offered by Petitioner be reflected in the amended Condition A. Condition A to read as follows:

"Petitioner shall provide housing opportunities for low and moderate income Hawaii residents by offering for sale, on a preferential basis, on its own or in cooperation with either or both the Hawaii Housing Authority or the County of Hawaii, ten percent (10%) of the lots or houses and lots to be developed on the subject property, to residents of the State of Hawaii of low and moderate family income as determined by the Hawaii Housing Authority from time to time. The preferential lots or houses and lots shall be offered for sale at prices not exceeding prices that enable such purchasers to qualify for and obtain state-assisted financing (e.g., Act 105 or Hula Mae) or federally-insured or assisted financing (e.g., FHA Section 245 Program) intended to encourage home ownership by low and moderate income families."

The motion was seconded by Commissioner Whittemore and unanimously carried by the following voice votes:

Ayes: Commissioner Hoe, Kajioka, Wada, Whittemore, Chun, and Chairman Nip.

Commissioner Himeno joined the proceeding at this time.
