Chairperson Hoe announced that the Commission would take action to consider reclassifying approximately 195 acres of land currently in the Agricultural District into the Conservation District at Makahanaloa, Papaikou, Paukaa, South Hilo, Hawaii for protection of native forest and forest bird habitat.

Benjamin Matsubara, Hearing Officer, presented his report and recommendations to the Commissioners.

Further arguments were heard from Mr. Eichor.

A letter dated March 15, 1995 from W.H. Shipman, Ltd. informing the Commission that an escrow was set up between W.H. Shipman, Ltd. and Conservancy Fund of Arlington, Virginia was submitted by the Office of State Planning to reflect that the Conservancy Fund will purchase the land from W.H. Shipman, Ltd. and then transfer it to the U.S. Government.

Commissioner Mattson moved to approve the hearings officer's report and recommendations regarding Docket No. A94-704 - Office of State Planning. The motion was seconded by Commissioner Kawakami and polled as follows:

A94-708 - OFFICE OF STATE PLANNING (Oahu)

Chairperson Hoe announced that the Commission would take action to consider reclassifying approximately 1,300 acres of land currently in the Agricultural District into the Urban District at Honouliuli, Ewa, Oahu, for land exchange, the University of Hawaii-West Oahu Campus, housing, and public facility uses.

Commissioners Nip and Kajioka were excused from this proceeding due to previously declared conflict of interest.

After hearing arguments, questions were asked by the Commissioners.

Chairperson Hoe announced that this matter would be taken under advisement and continued until April 6, 1995 on Kauai. The parties were allowed to file additional arguments.
