### OTHER PENDING MATTERS

- 1. Mr. Saruwatari gave a legislative update of two bills that were being monitored. H.B. 550, regarding HCDCH's motions before the Land Use Commission (Villages of Kapolei, Leiali`i, and La`i`opua), is currently in conference committee and a meeting has been scheduled for Monday, April 23, 2001. The other bill is SB 1473, relating to the Office of Planning's Smart Growth bill, which is in conference committee but no meeting has been scheduled at this time.
- 2. Tentative Meeting Schedule Mr. Saruwatari reported that a meeting date for May 17 has been scheduled to include a possible special permit matter relating to Fong Construction, in addition to a presentation by staff regarding the annual reports and the status report in Docket No. A92-679/White Hat Development Corp.
- 3. Status of LUC Budget Mr. Saruwatari reported that an Executive Memorandum was issued regarding restrictions on filling vacant positions. All positions that were previously approved by the Director of the Department now has to be approved by the Governor. This may affect filling of the vacant secretary position.
- 4. Litigation Update <u>Pacific Star, LLC v. The Sierra Club, et al.</u>, Civil No. 00-1-0209K (3<sup>rd</sup> Circuit). Commissioner Yukimura moved to go into executive session to discuss legal matters relating to the litigation update with our deputy attorney general. The motion was seconded by Commissioner Coppa and unanimously approved by voice votes.
