#### **MISCELLANEOUS**

#### 1. ADOPTION OF MINUTES

Commissioner Yukimura moved to approve the minutes for the meeting date of August 23 and 24, 2001. The motion was seconded by Commissioner Jarman and unanimously approved by voice votes.

#### 2. OTHER PENDING MATTERS

a. Tentative Meeting Schedule – Executive Officer Anthony Ching reported that continued hearings on the TSA petition would be conducted in Hilo on October 3 and 4, 2001. Action on the Klein petition as well as the Coast Guard Special Permit will probably be held on October 4, 2001. Mr. Ching also announced that a Commission retreat will be held on December 7, 2001. Mr. Ching will present and have discussion available to what he sees as

strategic goals from his standpoint. Mr. Ching will also bring the Commission up to date on discussion that is now occurring at the legislature with regards to the agricultural district. Other items for discussion will include the sunshine laws, ethics, and the formulation of decision and orders protocol. The Commission has been advised by Deputy Attorney John Dellera that this retreat is covered by the sunshine law and will be an open hearing which will be noticed to the public.
