# I. ADOPTION OF MINUTES

Commissioner Coppa moved to approve the minutes for the meeting of December 5-6, 2002. The motion was seconded by Commissioner Fiesta and said motion was unanimously approved by voice votes.

## III. CONTINUED ACTION

#### A. DR02-26 - KULEANA KU'IKAHI, LLC (Maui)

Chair Ing announced that the matter before the Commission was a continuation of the action meeting previously held on November 15, 2002 to consider (i) Petitioner's Petition for a Declaratory Order declaring that the subdivision and development of approximately 4,500 acres of land in the Agricultural District situated at Lahaina, Maui requires a district boundary amendment; (ii) Makila Land Company, LLC's Petition to Dismiss Petition for a Declaratory Order dated September 30, 2002, or in the Alternative, Set Matter for Hearing; and (iii) Kauaula Land Company LLC's Request for Hearing under HAR Section 15-15-103 as a Contested Case, Petition to Intervene under HAR Section 15-15-53 and Arguments in Opposition to Petition for Declaratory Order.

Upon reconvening the meeting, Chair Ing directed Executive Officer Ching to summarize some of the additional written testimony received to date. Executive Officer Ching summarized the testimony of Bruce Curtis, Robert and Debra Cohn, Mike Segura and Mario Kato as supporting the current developer and the project. Chair Ing then announced that after having heard six written testimonies, five hours worth of public witnesses, he would recommend to the Commission that public testimony be halted and that this action be set for a contested hearing. Chair Ing added that at that time, the Commission would seek to hear from expert and public witnesses and have the appropriate government agencies appear before this Commission. However, public witness Kalani Kapu raised an objection and requested opportunity to testify. His request was granted.

(3:10 p.m. Commissioner Catalani's appearance)

Further objections were raised by Kahaunani Keahi and Ruth Keahi to testify on behalf of the Kingdom of Hawaii so they were also allowed to testify.

Chair Ing asked the respective interested respondents for their comments. After extensive citation of the law, Mr. Kudo argued that the petition was defective and should be dismissed or, in the alternative, set for hearing. Mr. Welch argued that lands included in the petition are not involved in these subdivisions and urged that he be admitted as an intervenor if the Commission decides on a contested case. The County of Maui favored dismissal of this case and stood on its earlier filing. The Office of Planning favored a contested hearing on the petition and recommended that a boundary amendment to rural designation be sought for the project.

Commissioner Coppa moved to deny the motion for dismissal of the Petition for a Declaratory Order. Commissioner Catalani seconded the motion. The Commissioners were polled as follows:

The motion passed with 7 ayes and 2 absent.

Commissioner Roehrig moved that pursuant to the Commission's rules, the Petition for Declaratory Order is neither denied nor granted and should instead be set for hearing. Commissioner Fiesta seconded the motion. The Commissioners were polled as follows:

The motion passed with 7 ayes and 2 absent.

Commissioner Roehrig then proposed amending the agenda to include adoption of orders; setting the Kuleana Petition for hearing and adopting an order denying the County of Maui's Petition for Declaratory Order in the Hale Kaula matter. Commission Fiesta seconded the motion. The Commissioners were polled as follows:
