# 1. A00-732 – TSA CORPORATION (Hawaii)

Acting Chair Ing announced that this was an action meeting to consider Petitioner's First Update, as amended, to the Land Use Commission's February 14, 2002 Findings of Fact, Conclusions of Law, and Decision and Order for a State Land Use District Boundary Amendment reclassifying approximately 102.016 acres from the Conservation District to the Urban District at Kaloko, North Kona, Hawaii, for the development of a mix of light industrial and industrial-commercial uses; then to consider Petitioner's Motion to Modify Condition No. 7 of the Land Use Commission's February 14, 2002 Findings of Fact, Conclusions of Law, and Decision and Order for a State Land Use District Boundary Amendment.

Russell Kumabe, LUC planner, provided the Commission with a staff report. Mr. Kumabe summarized the positions taken by the various parties and Commission actions in this docket.

Commissioner Sakumoto disclosed that TSA is a client of his firm McCorriston Miller Mukai Mackinnon and that he has done work with TSA on other projects or unrelated matters but felt that he can be fair and impartial in this proceeding. Chair Ing polled the parties for their comments or observations with respect to Commissioner Sakumoto's declaration. The Petitioner, County of Hawaii, State Planning, and Honokahua Park (Intervenor) all indicated that they had no objection to record with respect to Commissioner Sakumoto's declaration and stated intention to participate in the proceeding.

A motion was made by Commissioner Roehrig and seconded by Commissioner Desai that Condition No. 7 be amended to modify the deadline for completion of Petitioner's housing needs assessment to within six months of the State's issuance of the updated Hawaii Housing Policy Study. There being a vote tally of 7 ayes, 0 nays and 2 excused, the motion carried.

A motion was made by Commissioner Roehrig and seconded by Commissioner Fiesta that the Petitioner provide to the Commission a letter or copy of a letter from the State Historic Preservation Division confirming that preservation is not needed for the archaeological sites specified in Condition No. 8 before there is any grubbing, grading, or bulldozing in the area. There being a vote tally of 7 ayes, 0 nays and 2 excused, the motion carried.
