A07-774 NORTH KONA VILLAGE, LLC (O'oma 2nd – Kaloko, North Kona, Hawaii)

Chair Piltz announced that this was a hearing on Docket No. A07-774 NORTH KONA VILLAGE, LLC (O'oma 2nd – Kaloko, North Kona, Hawaii) to consider the reclassification of approximately 181.169 acres of land currently in the Conservation District into the Urban District at O'oma 2nd Kaloko, North Kona, Hawaii, Tax Map Key Nos.: (3) 7-3-009:004 (portion), and 7-3-009 (portion of State Right-of-Way) for beachside residential community with mixed uses.

PUBLIC WITNESSES

1. Elizabeth Lee-

Ms. Lee shared her family history and reasons for supporting the Project. Ms. Benck asked if Ms. Lee supported the development of the Project. Ms. Lee responded that she did, with the condition that open space and access to the beach area be preserved. Commissioner Judge asked if Ms. Lee had seen the plan. Ms. Lee replied that she had and supported the Project. There were no other questions for Ms. Lee.

Joel Gimble –

Mr. Gimble stated his concerns about the Project and why he opposed it. There were no questions for Mr. Gimble.

3. Joseph Ka'apu –

Mr. Ka'apu stated that he was an attorney and shared his community affiliations. He represented himself as an individual and provided his reasons why he was in favor of the Project. There were no questions for Mr. Ka'apu.

4. Reggie Lee –

Mr. Lee testified in support of the Project and provided the reasons for his position. There were no questions for Mr. Lee.

5. Jon Miyata –

Mr. Miyata stated that he represented the Hawaii Island Chamber of Commerce and testified in support of the Petition. He shared the history of his organization and provided the reasons why it supported the Project. There were no questions for Mr. Miyata.

6. Myles Miyasato

Mr. Miyasato stated that he represented the Hawaii Operating Engineers Industry Stabilization Fund and submitted oral and written testimony in support of the Project. There were no questions for Mr. Miyasato.

7. Virginia Isabell

Ms. Isabell shared her experiences with the Project and provided oral and written testimony in support of the Petition. There were no questions for Ms. Isabell.

8. Randy Botti

Mr.Botti stated that he represented the Island Paddle Sports Association and testified in support of the Project. There were no questions for Mr. Botti.

9. Kathy McMillen

Ms. McMillen submitted written testimony with attachments and maps depicting the radar flight tracks and noise contours for the Petition Area. She shared her work experience and provided her perspectives of why she felt that development should not occur so close to the airport area.

Ms. Benck asked if Ms. McMillen was aware that the Petitioner had been meeting with the Department of Transportation-Airports Division over the airport noise issues. Ms. McMillen acknowledged that she knew about the talks and discussion ensued over acceptable noise levels in the Petition Area.

Mr. Yee asked about mitigation measures that might be employed if the Project were to move forward. Ms. McMillan provided her perception of why no mitigation measures would work and why she felt that light industrial use, although less attractive, might be more appropriate than residential use.

Commissioner Judge inquired which map was being referred to. Ms. McMillen referenced the material that she had submitted. There were no further questions for Ms. McMillen.

10. Marjorie Erway

Ms. Erway read the written testimony submitted by Duane Erway, President-Plan to Protect Kona. The testimony cited the reasons why Mr. Erway opposed the Petition.

Ms. Benck asked if Ms. Erway was aware of the actual number of residential units for the Project and that the Petition Area was within the Kona Community Development Plan Urban Area Land Use Plan. Ms. Erway responded that she had obtained her information about the number of Project units from the newspaper and was not able to speak to the Land Use Plan. There were no further questions for Ms. Erway.

11. Debbie Hecht

Ms. Hecht stated that she had submitted written testimony and provided her reasons for opposing the Petition.

Ms. Benck asked Ms. Hecht what her understanding of the open space ranking for the airport area was. Ms. Hecht shared her understanding of the issue. There were no other questions for Ms. Hecht.

12. Damien Silva

Mr. Silva provided his reasons why he supported the Project. There were no questions for Mr. Silva.

13. Eugene "Bucky" Leslie

Mr. Lewis read his submitted written testimony in support of the Project. There were no questions for Mr. Lewis.

14. Claire Bajo

Ms. Bajo read her submitted written testimony in support of the Project. There were no questions for Ms. Bajo.

15. Mark Travalino

Mr. Travalino stated that he was speaking on behalf of the Hawaii Laborers Union Local 368 in support of the Petition and shared the reasons for his organization's position. There were no questions for Mr. Travalino.

16. David "Bones" Inkster

Mr. Inkster read from his submitted written testimony and shared his reasons for opposing the Petition. There were no questions for Mr. Inkster.

17. Andy Bolander

Mr. Bolander read a letter from the University of Hawaii Sea Grant College program to Peter Young regarding the attributes of the Project. There were no questions for Mr. Bolander.

18. Janice Palma-Glennie

Ms. Palma-Glennie stated that she was speaking on behalf of the Sierra Club Makaloa Group and provided the reasons why her organization was against the Project. She submitted an information map reference for the Commission. Commissioner Lezy inquired if Ms. Palma-Glennie held a position in the Sierra Club organization. Ms. Palma-Glennie responded that she was the West Hawaii Co-Chair and described the activities and issues of her organization. There were no further questions for Ms. Palma-Glennie.

19. Shannon Rudolph

Ms. Rudolph provided her reasons why she was against the Project. She stated that she had collected Petitions with over two thousand signatures against development in the area. There were no questions for Ms. Rudolph.

20. Gary Orton

Mr. Orton provided his reasons why noise sensitive development should not be allowed in the Petition Area. There were no questions for Mr. Orton.

21. Leona "Noni" Roberts

Ms. Roberts shared her perspectives of why the Petition should be denied. There were no questions for Ms. Roberts.

22. Michelle Tomas

Ms. Tomas provided her reasons for opposing the Petition. There were no questions for Ms. Tomas.

23. Ruth Aloua

Ms. Aloua shared her reasons for denying the development of the Project. There were no questions for Ms. Aloua.

24. Barbara Scott

Ms. Scott shared her community background and association with the Traffic Safety committee and described why she supported the Petition. Mr. Yee requested clarification on who Ms. Scott was speaking for. Ms. Scott replied that this was her personal testimony. There were no further questions for Ms. Scott.

Ms. Eoff read from her submitted written testimony on behalf of her organization –Kohanaiki 'Ohana and provided the reasons why it opposed the Petition. There were no questions for Ms. Eoff.

Ms. Pilago shared her reasons for opposing the Petition. There were no questions for Ms. Pilago.

27. Rebecca Villegas

Ms. Villegas stated that she was President of Kohanaiki 'Ohana and provided the reasons for her organization's opposition to granting the Petition. There were no questions for Ms. Villegas.

28. Tracy Solomon

Ms. Solomon submitted written testimony and provided her concerns and reasons why she opposed the Petition. There were no questions for Ms. Solomon.

29. Robert Freitas Jr.

Mr. Freitas read from his submitted testimony and shared his family history and reasons for opposing the Project. There were no questions for Mr. Freitas.

30. Charles Flaherty

Mr. Flaherty stated that he was President of 'Apono Hawaii and read his submitted written testimony that provided the reasons why his organization opposed the Petition. There were no questions for Mr. Flaherty.

31. Brock Stratton

Mr. Stratton stated that he represented the Surfrider Foundation Kona Kai Ea Chapter and submitted written testimony for his organization and for Stuart Coleman- Hawaii Coordinator-Surfrider Foundation. Mr. Stratton provided the reasons why his organization opposed the Petition. There were no questions for Mr. Stratton.

32. Jeffrey Middleton

Mr. Middleton expressed his concerns about the Project and provided the reasons for his opposition to the Petition. There were no questions for Mr. Middleton.

33. Laura Aquino (spoke on behalf of Curtis Muraoka)

Ms. Aquino read the submitted written testimony of Curtis Muraoka and other members of the O'oma Beachside Villages Citizen Advisory Group and provided the reasons why the group supported the Petition. There were no questions for Ms. Aquino.

34. Cheryl King

Ms. King asked that the Commission deny the Petition and provided her reasons for her request. There were no questions for Ms. King.

35. John Knoll

Mr. Knoll stated that he was testifying for the Project since it addressed more issues than any others that he had worked on. There were no questions for Mr. Knoll.

36. Robert Meierdiercks

Mr. Meierdiercks stated that he represented the West Hawaii Carpenters union and provided the reasons why his organization supported the Petition. There were no questions for Mr. Meierdiercks.

37. Marian Wilkins

Ms. Wilkins described her participation in the community planning for the Project and expressed her reasons to deny the Petition. There were no questions for Ms. Wilkins.

Mr. Wilkins described his past work as a Principal Investigator with the University of Hawaii and provided his reasons why the shoreline land should remain in the Conservation District.

Commissioner Judge requested clarification on the drilling technology utilized in the study and on what the purpose of the drilling was for. Mr. Wilkins provided his recollection of his past work.

Commissioner Kanuha requested clarification on how conclusive the data collected by the University was. Mr. Wilkins responded that the data was inconclusive and described the reasons for his conclusion.

Commissioner Judge requested clarification on findings regarding nitrogen levels in the water. Mr. Wilkins provided his opinion on how the information might have been discovered. There no further questions for Mr. Wilkins.

39. Alfredo Martinez

Mr. Martinez stated that he was in favor of the Project and provided the reasons for his position. There were no questions for Mr. Martinez.

40. Michael Akau

Mr. Akau stated that he represented the Hawaii Operating Engineer's Union, Local 3, District 17. He read his submitted written testimony that provided the reasons why his organization supported the Project. There were no questions for Mr. Akau.
