PETITIONER PRESENTATION

Mr. Mee provided a brief history and background summary on the Petition and argued why the Declaratory Order should be granted.

Commissioner Chang requested clarification on the scope of the waiver being requested by the Petitioner. Mr. Mee described the specifics of what was being requested in the waiver and how granting the waiver would allow the County greater flexibility in accomplishing its project goals. There were no further questions from the Commissioners.

Chair Aczon inquired whether OP had any public testimony. Ms. Apuna replied that OP had no opposition to the Petition.

There were no further questions for Mr. Mee or OP.
