Commissioner Scheuer described his role with the Hawaiian Island Land Trust and his awareness of some preliminary business discussions occurring between Hawaiian Memorial Park and the Hawaiian Island Land Trust; but believed that he could remain fair and impartial during the proceedings.

There were no objections to Commissioner Scheuer's continued participation.

Chair Wong disclosed that his family members had used Hawaiian Memorial's cemetery services; but felt that he could remain fair and impartial during the proceedings.

# **PRESENTATION**

Petitioner

Mr. Tabata made his presentation to the Commission and argued why the LUC should be the accepting authority for the Environmental Impact Statement ("EIS") and why an EIS was warranted; and described the reasons why his motion should be granted.

#### AGENCY COMMENTS

County

The County stated that it had no objection to the motion.

There were no questions for County.

Ms. Apuna stated that OP had no objection to the motion. There were no questions for Ms. Apuna.

There were no further questions.

Commissioner Chang moved to enter into Executive Session. Commissioner Scheuer seconded the motion. By unanimous voice vote (6-0-3 excused), the Commission voted to enter into Executive Session 09:49 a.m. and reconvened the meeting at 10:00 a.m.

#### **DECISION MAKING**

Commissioner Mahi moved to approve the Petition. Commissioner Cabral seconded the motion.

Commissioner Okuda requested clarification on whether Commissioner Mahi's motion would:

- 1) Identify the Commission as the "accepting authority," to review and accept the applicant's proposed actions pursuant to Chapter 343, HRS; and,
- 2) Direct the Petitioner to prepare an EISPN because the Commission determined, based on its judgment and experience, that under Chapter 343-5(e), HRS, the proposed action may have significant effects requiring the preparation of a full environmental impact statement.
- 3) Authorize the Executive Officer to notify and submit a record of the Commission s decision to OEQC by the November 15, 2017, deadline. It was further recommended that the motion specify that the Commission authorizes the Chair to sign any Order on this matter on behalf of the Commission.

Commissioner Mahi acknowledged his agreement with Commissioner Okuda's understanding of the motion. Commissioner Cabral also acknowledged and agreed with Commissioner Okuda's understanding of the motion.

Commissioner Scheuer requested clarification that the specifics of the motion and its friendly amendment just addressed the LUC's role as accepting authority and not the approval of the EIS. Chair Wong acknowledged that the motion was limited to the LUC's being the accepting authority.

There was no further discussion.

Chair Wong had Mr. Orodenker poll the Commission.

The Commission unanimously voted in favor of the motion with the friendly amendment. (6-0-3 excused).

Chair Wong declared a recess at 10:03 a.m. and reconvened the meeting at 10:05 a.m. and moved on to the next agenda item.

# **PRESENTATION**

Petitioner

Mr. Niermann made his presentation to the Commission and argued why the Special Permit should be granted. Mr. Niermann and Mr. Inouye responded to requests for clarification on Petitioner's presentation from Commissioners Cabral, Chang and Scheuer.

Chair Wong stated that he had failed to get acknowledgment from Mr. Niermann and Mr. Inouye that the testimony they were providing to the Commission was truthful. Mr. Niermann and Mr. Inouye affirmed that their testimonies were truthful.

# County

Mr. Takahashi stated that County was in support of the permit and recommended approval.

There were no questions for Mr. Takahashi.

OP

Ms. Apuna stated that OP had reviewed the permit and expressed its support for the expansion of the HWWTP to accommodate secondary treatment and support facilities. OP acknowledged Petitioner's plans to file both a motion to amend the Findings of Fact, Conclusions of Law, and Decision and Order issued in Docket No. A88-627 to bifurcate TMK: 9-1-069: 3 from the original reclassification and a district boundary amendment petition to reclassify the Petition Area to the State Land Use Urban District.

There were no questions for Ms. Apuna.

#### **DECISION MAKING**

Chair Wong entertained a motion.

Commissioner Okuda moved to approve the Special Permit application for the HWWTP. Commissioner Mahi seconded the motion.

# Discussion

Commissioner Okuda described the reasons why he had moved to approve the Special Permit application and why it should not be a precedent for other permits.

Commissioner Scheuer described his disappointment with the need to approve a Special Permit in lieu of a District Boundary Amendment ("DBA") for the HWWTP since it appeared that there was sufficient time to be more efficient in this matter.

Chair Wong declared a recess at 10:45 a.m. and reconvened the proceedings at 10:47 a.m.

Chair Wong echoed Commissioner Scheuer's disappointment that a DBA had not been pursued earlier.

Commissioner Cabral expressed her concerns about the compatibility of the landscaping of the proposed project with areas beyond the project boundaries.

Commissioner Okuda stated that he wished to clarify that his motion:

- 1. Required that the metes and bounds map and description be signed and stamped by a registered professional land surveyor and that copies of the map and description be provided to the LUC;
- 2. Required the submittal and approval of a TIAR to the DOT, Highways Division;
- 3. Required Petitioner to obtain the approval of the LUC for any time extension to the deadline by which Petitioner is to apply for a State Land Use District Boundary Amendment with the LUC and to file a motion to amend the Findings of Fact, Conclusions of Law, and Decision and Order issued in Docket No. A88-627;-
- 4. Added an additional condition to require Petitioner to cease all work and immediately contact the SHPD and Oʻahu Burial Council in the event historic or cultural resources are identified during demolition and/or construction activities and to obtain an archaeological clearance from the SHPD if required;
- 5. Required Petitioner to obtain the approval of the LUC for any time extension to the deadline by which Petitioner is to establish the Project;
- 6. Authorized staff to make non-substantive changes to the conditions, as appropriate, regarding formatting, style, and other modifications to ensure consistency; and
- 7. Authorized the Chair to sign the Order in this matter on behalf of the Commission.

Commissioner Mahi stated that he agreed with Commissioner Okuda's clarification.

There was no further discussion.

Chair Wong had Mr. Orodenker poll the Commission.

The Commission unanimously voted in favor of the motion. (6-0-3 excused)

Commissioner Cabral moved to enter into Executive Session. Commissioner Mahi seconded the motion. By unanimous voice vote (6-0-3 excused), the Commission voted to enter into Executive Session.

The Commission entered Executive Session at 10:59a.m.

(Commissioner Scheuer excused himself from the meeting with the approval of the Chair at 11:03 a.m. and did not return.)
