#### HAWAII TAX ONLINE PAYMENT METHODS

- This presentation will give an overview of Loan—Out Company General Excise Tax (GET) Withholding Payments on Hawaii Tax Online (HTO) (hitax.hawaii.gov) based on HTO configuration as of January 12, 2023 (subject to change).
- There are 2 methods to make a loan-out GET withholding payment via HTO:
  - 1. Payment with existing HTO account
  - 2. Payment without existing HTO account



### PAYMENT WITH HTO ACCOUNT

### Who can make a loan-out GET withholding payment with an HTO account?

- Master account holder for a Corporation, Partnership or Limited Liability Company with a Federal Employer Identification Number.
- Master account holder by default is the 1<sup>st</sup> person creating the account at HTO.
- Taxpayers will be able to view historical payment submissions at HTO after they sign-in into their account.



### PAYMENT WITHOUT HTO ACCOUNT

#### Who can make a loan-out GET withholding payment without an HTO account?

- A taxpayer, tax preparer, or agent is not required to set up an HTO account to make payments.
- Anyone can make loan-out payments on behalf of a production company.
- A taxpayer, tax preparer, or agent must print/save a copy of the payment submission for their records.
- There is no ability to view historical filing/payment for non sign-in option.



### INFORMATION REQUIRED FOR HTO PAYMENTS

#### Production Company

- A valid Federal Employer Identification Number (FEIN)
- ✓ Production company name, address, and phone number

#### Loan-Out Company Information

- √ Loan-out company name
- ✓ Loan-out company general excise number (GE-xxx-xxx-xxx)

#### Payment Information

- Date of payment to loan-out company
- ✓ Gross amount paid to loan-out company by district (Oahu, Maui, Hawaii, and Kauai)
- ✓ Account and routing number for the bank account that will be used to make the payment
- Payments from foreign bank accounts, credit cards, or debit cards are not supported


#### PAYMENT DUE DATE

- Amount withheld from payments made to loan-out company must be paid to DOTAX no later than 20 days of the calendar month following the month in which the payment was made to the loan-out company.
- Payment must be made in full.

- 3. Follow the steps to submit payment

#### **About This Submission**

This submission allows you to submit a general excise withholding payment for all payments made to loan-out company for services performed in Hawaii per Act 217, SLH 2022 (withholding of tax by persons claiming the motion picture, digital media, and film production income tax credit).

Amount withheld from payments made to loan-out company must be paid to Department of Taxation no later than 20 days of the calendar month following the month in which the payment was made to the loan-out company.

#### What You Need



Production Company Information:

- A valid Federal Employer Identification Number (FEIN)
- · Production company name, address, and phone number

Loan-Out Company Information:

- Loan-out company name
- Loan-out company General Excise number (GE-XXX-XXX-XXX)

#### Payment Information:


- · Date of payment to loan-out company
- · Payment amount by district (Oahu, Maui, Hawaii, and Kauai)
- Account and routing number for the bank account that will be used to make the payment. Payments from foreign bank accounts, credit cards, or debit cards are not supported

#### Submission Instructions

Use the buttons at the bottom of each page to navigate each step. You cannot move to the next step unless all fields are completed without an indicated error. Your submission will not be filed until you click the **Submit** button on the final step. **Your session will be locked after 15 minutes of inactivity.** 






If you don't know the loan-out GET license number, you are able to search/validate




### PAYMENT WITHOUT AN HTO ACCOUNT STEPS PAYMENT DATE


- Select the district(s) where loan-out services were performed
- If multiple payments were made in a month, one single remittance by the due date suffices
  - For payment date, use the date of the last payment made for the month to loan-out






# PAYMENT WITHOUT AN HTO ACCOUNT STEPS GROSS PAYMENT BY APPLICABLE DISTRICT





# PAYMENT WITHOUT AN HTO ACCOUNT STEPS SUMMARY


- The Summary of Taxes Due page will list all 4 taxation districts, for your review






### PAYMENT WITH HTO ACCOUNT STEPS

- Follow the steps to submit payment




# PAYMENT WITH HTO ACCOUNT STEPS INITIAL AND SUBSEQUENT PAYMENT

For an initial payment: Go to "Make a Loan-out Payment"




For a subsequent payment: Locate the Loan-out, select "Pay Again"

- Print/save a copy of payment submission confirmation page for your record




### PAYMENT WITH HTO ACCOUNT STEPS CONFIRMATION
