The exemption application must include a statement of the specific reason(s) why you are unable to comply with the requirements. Additional supporting documentation may be submitted along with the exemption application. Unwillingness, computer

system failure, break in internet coverage or failure to maintain internet access would not be considered good cause for an exemption.
