RE: Form G-37, "General Excise/Use Tax Exemption for Certified or Approved Housing Projects"

This Announcement supercedes Announcement No. 2000-24, dated December 5, 2000.

Form G-37 is used by government agencies to certify that persons receiving gross income from the planning, design, financing, construction, sale or lease of a qualified low or moderate income housing project are exempt from the general excise tax under section 237-29, Hawaii Revised Statutes. This Announcement reflects changes to contact information for agencies that certify the form.
