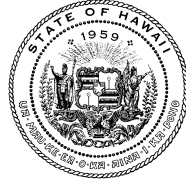

## DEPARTMENT OF TAXATION ANNOUNCEMENT NO. 2017-06

RE: Revised Hawaii County Fuel Tax Rate, Effective August 1, 2017

Hawaii County Resolution No. 212-17 (Draft 2) increases the county of Hawaii's fuel tax rates effective August 1, 2017. The county of Hawaii fuel tax rates are:

Gasoline & Diesel Oil	\$0.150 per gallon
Naphtha not used in a power-generating facility	\$0.150 per gallon
Biodiesel	\$0.000 per gallon
Ethanol	\$0.022 per gallon
Methanol	\$0.017 per gallon
Liquefied Petroleum Gas (LPG)	\$0.050 per gallon
Compressed Natural Gas (CNG)	\$0.074 per gallon
Liquefied Natural Gas (LNG)	\$0.074 per gallon

Alternative Fuels rates changed due to the increase in the county diesel rate. The fuel tax increases apply to fuel sold or used by distributors on or after August 1, 2017 (including stock that was purchased by distributors before August 1, 2017, but sold or used by distributors on or after August 1, 2017). See the attached "Schedule of Fuel Tax Rates (Effective August 1, 2017)" for all counties.

This resolution also provides for increases in the fuel tax rates for diesel, gasoline, and liquid fuel sold or used by a distributor effective July 1, 2018 and July 1, 2019. The Department of Taxation will release an announcement for each increase in a timely manner before implementing the fuel tax increases.

The applicable fuel tax forms are being revised and will be available shortly at the district offices of the Department of Taxation. Forms and other tax information may be downloaded from the Department's website at [tax.hawaii.gov](http://tax.hawaii.gov).
