## **DEPARTMENT OF TAXATION ANNOUNCEMENT NO. 2025-07**

RE: Adoption of Amended Hawaii Administrative Rules Section 18-235-61-06, Relating to Income Tax Withholding Tables for Taxable Years Beginning After December 31, 2025

On June 3, 2024, Governor Josh Green, M.D. signed into law Act 46, Session Laws of Hawaii 2024. Act 46 increased the standard deduction amounts for tax year 2024, and amended the income tax brackets by increasing the income limits in each bracket for tax year 2025.

## Act 46 additionally increases the standard deduction amounts for tax year 2026.

Pursuant to chapter 91, Hawaii Revised Statutes (HRS), the Department of Taxation (DOTAX) amended section 18-235-61-06, Hawaii Administrative Rules (HAR), to incorporate updated income tax formulas and withholding tables for tax year beginning after December 31, 2025. The amended rule was adopted after a public hearing on October 30, 2025, and is effective on December 5, 2025.
