**DEPARTMENT OF TAXATION SUMMER WORKSHOP 2003
ON OAHU AND NEIGHBOR ISLANDS**

HONOLULU—The Department of Taxation will be conducting its Summer Workshop 2003 from 8:30 A.M. to 12:30 P.M. on Oahu, Maui, Hawaii, and Kauai (see schedule on the following page).

Topics include a review of 2003 tax legislation, tax issues relating to the high technology business investment tax credit and the tax credit for research activities, offers in compromise and more!

The cost for the workshop is \$40 for persons registering at least two weeks prior to the workshop date. An additional \$5 fee is charged for late registrations. The cost includes a continental breakfast, workshop materials, and the Hawaii Tax Laws and Administrative Rules CD. Four hours of Continuing Professional Education (CPE) credit also will be given.

Workshop materials are being offered separately for \$15 a set to anyone who is unable to attend one of the workshops or who would like additional sets of materials.
