**DEPARTMENT OF TAXATION YEAR-END WORKSHOP 2003
ON OAHU AND NEIGHBOR ISLANDS**

HONOLULU—The Department of Taxation will be conducting its Year-End Workshop 2003 from 9:00 A.M. to 1:00 P.M. on Maui, Kauai, Oahu, and Hawaii beginning this month (see schedule on the next page).

Topics include what's new for the coming tax season, State tax forms update, civil and criminal tax cases, pending administrative tax rules, administrative guidance on various issues, the Electronic Federal Tax Payment System (a special presentation by the IRS), and more!

The cost for the workshop is \$45 for persons registering by November 13, 2003, for the Maui Workshop, or at least two weeks prior to the date of the other workshops. An additional \$5 fee is charged for late registrations. The cost includes continental breakfast, workshop materials, and a \$5 discount on the 2003 Hawaii Tax Information CD that will be released in January 2004. Four hours of Continuing Professional Education (CPE) credit also will be given.

Workshop materials are being offered separately for \$15 a set to anyone who is unable to attend one of the workshops or who would like additional sets of materials.
