**DEPARTMENT OF TAXATION 2005 YEAR-END WORKSHOPS
ON OAHU AND NEIGHBOR ISLANDS**

HONOLULU—The Department of Taxation's Year-End Workshop 2005 series will begin on Monday, November 28, 2005, with its first session on Kauai. The remaining workshops on Oahu, Kona, Hilo, and in Maui will be held in December (see schedule on the following page).

All workshops begin at 8:00 A.M. and end at 12:00 P.M. Presentation topics include State tax form and other changes for the 2005 filing season, county surcharge tax, Streamlined Sales and Use Tax project, tax relief bills, tax litigation update, criminal investigations, and more!

The cost for the workshop is \$60 for persons registering at least two weeks prior to the workshop date. An additional \$5 fee is charged for late registrations. The cost includes continental breakfast, workshop materials, and the 2005 Tax Information CD. Four hours of Continuing Professional Education (CPE) credit also will be given. Workshop handouts can be separately ordered for \$15 a set.
