**Department of Taxation Announces
Summer 2012 Tax Workshops**

HONOLULU — The Department of Taxation's Summer 2012 Tax Workshops on O'ahu, Maui, Hawai'i, and Kaua'i will begin in Hilo on July 13, 2012 (see the full schedule on the next page).

Presentations will include a review of the recently concluded 2012 tax filing season and an update of the Department's e-filing program. Director of Taxation Fred Pablo and other staff will provide an overview of the 2012 legislative session and discuss some of the key measures enacted this year. Also on the agenda is an overview of the Special Enforcement Section's efforts to address the cash economy and an update on their recent activities.

"We're pleased to present these workshops for the state's tax professionals," said Director of Taxation Fred Pablo. "We value the opportunity to work with the tax community and hear their ideas and suggestions."

All workshops will begin at 8:30 a.m. and end at 12:30 p.m., with check-in beginning at 8 a.m.

The cost for the Summer Workshop is \$80 for each person registering at least one (1) week prior to the selected workshop, and \$100 for those who register after that. The registration fee includes a continental breakfast, all workshop materials, and four (4) hours of Continuing Professional Education credit. Additional workshop materials may also be purchased separately for \$25 per set.
