**Department of Taxation Announces  
2013 Summer Tax Workshop Schedule**

HONOLULU — The Department of Taxation's 2013 Summer Tax Workshops, scheduled for O'ahu, Maui, Hawai'i, and Kaua'i, will kick-off on Kaua'i on July 16, 2013.

This year's workshop topics include the Department's voluntary disclosure program; an update on the expiration of Act 105; general excise tax exemptions; and key tax measures passed during the recently concluded 2013 legislative session.

"We're pleased to present our annual Summer Workshops for the state's tax professionals," said Director of Taxation Fred Pablo. "These workshops provide us a chance to update and educate our tax community on issues, as well provide the community an opportunity to share their ideas and suggestions."

All workshops run from 8:30 a.m. to 12:30 p.m., with registration starting at 8:00 a.m. The fee is \$80 for persons who submit their registration and payment by the deadline. Late registrations are \$100. Walk-in registrations will be accepted at the door on a space-available basis. The fee includes a continental breakfast, workshop materials, and four (4) hours of Hawai'i Board of Public Accountancy Continuing Professional Education credit. Workshop materials may be separately purchased for \$25 per set.
