Effective July 1, 2010, the environmental response tax (ERT) rate increased from \$0.05 to \$1.05 per barrel.

Effective July 1, 2015, the ERT includes a tax on fossil fuels (not including petroleum products) at \$0.19 per million British thermal units.

*Fuel tax collections were \$16,204,257.77 in October. Of the collections, \$100,294.67 could not be distributed because the corresponding tax returns were not yet available. The \$1,460,371.34 undistributed fuel tax in September 2016 is included in the October 2016 report.
