Effective July 1, 2015, the environmental response tax (ERT) includes a tax on fossil fuels (not including petroleum products) at \$0.19 per million British thermal units.

Effective July 1, 2019, the allocation of ERT to the energy security special fund changes from 15 cents to 5 cents of the tax on each barrel.

*Fuel Tax collections were \$169,413,263.18 for fiscal year 2020. Of the collections, \$257,635.80 could not be distributed because the corresponding tax returns were not yet available.
