6/ Fuel tax collections were \$14,788,009 in July 2021, of which \$4,297 could not be distributed because the required tax returns were not yet available.

7/ Governor Ige's Sixth Supplementary Proclamation suspended Section 237D-6.5(b), Hawaii Revised Statutes, for the month of July in 2021. The Section distributes part of the transient accommodations tax (TAT) to the counties and to various special funds. With the suspension, all of the TAT collections for July in 2021, with the exception of the special levy for Honolulu's rail project, went to the general fund.
