6/ Fuel tax collections were \$165,231,515 for calendar year 2021, of which \$61,118 could not be distributed because the required tax returns were not available. Fuel tax collections were \$146,560,018 for calendar year 2020. A total of \$593,352 in undistributed fuel taxes from previous years were included in several monthly reports in calendar year 2020.

7/ Governor Ige's Sixth Supplementary Proclamation suspended Section 237D-6.5(b), Hawaii Revised Statutes, for the months from May through December of calendar year 2020, and for the months from January through May and July of calendar year 2021. The Section distributes part of the transient accommodations tax (TAT) to the counties and to various special funds. During the suspension, all of the TAT collections, with the exception of the special levy for Honolulu's rail project, went to the general fund.
