OVERVIEW OF LAHAINA RECOVERY BY GOVERNOR JOSH GREEN, M.D.

Agenda item five was moved up to the first order of business to give ample time to Governor Green to address the situation with the Maui fires and the plans for the recovery.

Governor Green addressed the State's plans for recovery:

- 1. Housing for people who have been displaced from homes.
- 2. Secure funds obtained through groups like FEMA (Federal Emergency Management Agency) and the Army Corps of Engineers.
- 3. Additional solutions for small businesses
- 4. Opening West Maui to tourism on October 8th with the exception of Lahaina

Ms. Maynard nominated Mr. Kawafuchi for another term as Chair.

<u>REVIEW OF REVENUES BY DR. SETH COLBY, TAX RESEARCH & PLANNING</u> <u>OFFICER:</u>

Dr. Colby asked the Council if it was ok with having agenda line items six and seven done simultaneously.

Dr. Colby began with legislation that has been passed and will have impacts on revenues:

- 1. Act 62, SLH 2023:
 - a. Amends the cigarette tax and tobacco tax. Beginning January 1, 2024, imposes a tax of 70% of the wholesale price of each electronic smoking device or e-liquid sold, used, or possessed by a wholesaler or dealer, whether or not sold at wholesale, or if not sold, then at the same rate upon the use by the wholesaler or dealer. The Act increases the wholesaler and dealer license fee from \$2.50 to \$250. It also increases the retail tobacco permit fee from \$20 to \$50. The Act became effective on July 1, 2023.
- 2. Act 163, SLH 2023
 - a. Amends the household and dependent care services credit by increasing the cap on employment-related expenses that may be used to claim the credit from \$2,400 to \$10,000 for one qualifying individual and from \$4,800 to \$20,000 for two or more qualifying individuals. Act 163 amends the EITC by increasing the amount of the credit from 20% to 40% of the federal EITC allowed. The Act also amends the refundable food/excise tax credit by doubling the amount of credit per qualified exemption and increasing the adjusted gross income limits by \$10,000 in all income brackets. Act 163 became effective on June 30, 2023, applies to taxable years beginning after December 31, 2022, and will be repealed on December 31, 2027.

Dr. Colby then discussed the current state of revenues, providing the following information to the Council:

<u>REVIEW OF RECENT LEGISLATION BY DR. SETH COLBY, TAX RESEARCH &</u> <u>PLANNING OFFICER:</u>

Dr. Colby simultaneously gave a review of legislation along with agenda line item six review of revenues presentation.

DISCUSSION AND VOTE ON THE GENERAL FUND TAX REVENUE FORECAST FOR FISCAL YEAR 2024:

Mr. Kawafuchi asked Dr. Bonham to start the discussion for FY2024.

Dr. Bonham said that model one provided by TRP is reasonable and is close to the Council's models.

Dr. Bonham gave his view on the impact of the Maui disasters with regard to the Council's forecast.

Dr. Bonham then provided the Council's inputs from table three which showed the average off all the forecasts.

Dr. Bonham thinks that the Council's average for GDP was a few points low from his viewpoint.

Dr. Bonham also thinks that visitor expenditures and visitor arrivals are not low enough.

Dr. Bonham finished up by sharing his thoughts on the construction growth rate and the impact it will have on the following years.

Mr. Hayashi asked if the construction numbers represent the actual construction in Hawaii or if the numbers are across the construction industry.

Dr. Colby responded that the number is the State's construction spending.

Dr. Bonham moved to adopt 1.3% growth rate from model one for FY2024.

Ms. Maynard seconded the motion for 1.3% growth rate for FY2024.

It was moved by Dr. Bonham and seconded by Ms. Maynard that the General Fund growth rate forecast be 1.3% FY2024. The Chair called for the vote, and the motion passed with the following votes:

Mr. Kawafuchi asked the Council if any of the members would like to start the discussion for FY2025.

Mr. Lee suggested following the model of 5.2% growth rate for FY2025.

Dr. Bonham seconded 5.2% growth rate for FY2025.

Ms. Maynard agreed with the 5.2% for FY2025 and suggested to reduce the growth rate come down s for FY2026 through FY2030.

Mr. Lee moved for 5.2% growth rate for FY2025.

Dr. Bonham seconded 5.2% growth rate for FY2025.

Mr. Kawafuchi asked if there was any further discussion.

There was no further discussion.

He provided a written report summary of significant changes primarily attributed to reimbursements of Health premiums, variances in of note in transfer of GET, unemployment insurance tax collection, and actual amounts of refunds rebates, and prescription drug plans.
